There are 4 provisions in our Constitution to stop any invasion into our land:

- 1: **SUPREMACY CLAUSE: ARTICLE 6. CLAUSE 2 AND 3**

This states: The Constitution is the Supreme Law of our land. This covers every inch of our land, including our waters, going into the surrounding ocean for 200 miles.

- 2: **ARTICLE 1. SECTION 9. CLAUSE 1**

This delegates Congress the power to control immigration.

- 3: **ARTICLE 4 SECTION 4**

This REQUIRES the Federal government to PROTECT the States from invasion.

- 4: **Article 1. Section 8. Clause 15**

This authorizes Congress to call for State militia to suppress insurrection and repel invasion.

What is a Constitutional Grand Jury of Common Law ?

- Continental Grand Jury of Common Law is the 4th. Branch of government pursuant to 1992 (see below)
- Ensures that our Constitutional Rights of and for All People are followed.

Fifth Amendment: Please look up the Fifth Amendment which protects this right.

The applicable Supreme Court Law:

Justice Antonin Scalia: ruling of 1992 “ The Grand Jury Belongs to The People”
The Continental Grand Jury of Common Law is the 4th. Branch of the Government.

The Grand Jury is mentioned in the Bill of Rights, but not in the body of the Constitution. It has not been textually assigned, therefore, to any of the branches described in the first three Articles. It “ *is a constitutional fixture in its own right.*” United States v Chanen ; United States v Williams.

“ the grand jury is an institution separate from the courts, over whose functioning the courts do not preside.

In fact, the whole theory of its function is that it belongs to no branch of the institutional government, serving as a kind of buffer or referee between the government and the people.”
